Second deposit (accession no. S88/1)

The second deposit of records of the National Union of Agricultural and Allied Workers consists of manuscript and printed material covering a wide range of financial and administrative activities of the union. There are also records for several associated organizations.

The records are mainly from the 1950s-1970s, although some sections contain material considerably pre-dating that. The records in class BXXXIV must remain closed until 2032. Access to some other records may be restricted, at the discretion of the archivist.
